

It doesn't matter how many tech-savants profess to promote it, the Cryptos like Bitcoin, are good as a speculative investment instruments, with their sole merit being that they could go up in value. But realistically, these currencies don't make up for a good medium of exchange because of their plaguing unpredictability that within a few days or weeks, their values could fluctuate too drastically, either going up sharply or come crashing down. In the long run, the 'well-known' cryptocurrencies aren't much safe for users to ally with for either utility or for investment.

Apart from unpredictability, lack of scalability is another major concern for current Blockchain networks. Current networks are capable of handling only a restricted amount of transaction data on their platforms in a given span of time, with their transaction processing capacity being limited to the average block creation time and the block

size limit. This leads to increase in transaction fees of conventional platforms and delayed processing of transactions owing to network congestion that affects the overall utility, feasibility and ease of adoption of any Blockchain network.


Alongside this, the initial ruling ideology behind creation of digital currencies, such as: ability to enable instant, borderless transactions, reduced transaction fees or exchange charges has greatly been gridlocked. Digital assets domain is plagued by price manipulation tactics involving pump-and-dump, whale walling aka order book spoofing, wash trading, stop-loss hunting, leveraged derivatives, spots and standard FUDs given the unregulated and nascent nature of the sphere. Many exchanges and investment whales have engineered organized "events" in the market in order to manipulate the price movements or liquidity of the virtual currencies unscrupulously.



CURRENT CHALLENGES & SCENARIOS IN CRYPTOSPHERE

Another considerable challenge associated with current cryptocurrencies is their employment in illegal trades, potential to discreetly fund terrorist agencies, money- laundering and avoidance of capital controls. While cryprocurrencies do provide a digital and anonymous payment mechanism, popular digital currencies, say-Bitcoin has unwittingly encouraged growth of "darknet" for conduct of illicit financing and trading practices.

It's also examined that most popular Blockchain networks and cryprocurrencies are extremely energy intensive, owing to their mining protocol to support accurate verification of all transactions on the network. University of Cambridge Centre for Alternative Finance (CCAF) studies found that Bitcoin alone, has a total energy consumption that is somewhere between 400 and 445 annualized



terawatt hours (TWh), while UK's electricity consumption is a little over 300 TWh a year. On top of this, the electricity required by the crypto-miners to "mine" the transactions come from extremely polluting sources, recording that about two-thirds of it is being sourced from fossil fuels. This makes these networks highly energy-reliant, leaving a heavy trail of carbon footprints in their wake. Hence, robust mining infrastructural reforms are necessary that can help support global blockchain communities rather than draining precious natural resources, and help prevent a threatening surge of greenhouse gas emissions.




UNDERLYING TECHNOLOGY

We have chosen Proof of Authority (PoA) technology to eradicate most of the problems associated with the current blockchain setup of Bitcoin. In PoA-based networks, transactions and blocks are validated by approved by validators. Validators are approved authority nodes who run put transactions in blocks by an automated program.

Main advantage with PoA, is that the individuals earn the right to become validators, so there is an incentive to retain the position that they have gained. We aim to attach a reputation to identity, validators are incentivized to uphold the transaction process, as they do not wish to have their identities attached to a negative reputation.

Such a system will be much more robust than existing PoS (proof-of-stake) which does not take into consideration the total holdings, and hence the incentives are unbalanced. In addition, PoA is suited for both private networks and public networks as it requires minimal computational capacity, doesn't require specialized equipment and also yield high throughput capacity.



UNDERLYING TECHNOLOGY



HOW WE USE THIS FOR COMMUNICATION BETWEEN BOTS




Public key cryptography allows robots to be sure that the content of a message can only be read by the owner of the corresponding sending address.


Digital signature cryptography provides away to prove the ownership of a specific address public key.

(a) Possible Solution 1: An available Unmanned Aerial Vehicle(UAV) provides its key to unlock the multisig address and retrieve the UTV position. The problem is solved by permitting the UAV to carry the UTV to the other side.

(b) Possible Solution 2: An available Unmanned Underwater Vehicle(UUV) provides its key to unlock the multisig address and retrieve the UTV's position. The action is fulfilled by letting the UUV carry the UTV to the other side.


